DIAGNOSTIC DUEL - CPC COMPETITION

GUIDELINES FOR SUBMISSION:

Dear Teams,

We request you to kindly adhere to the following guidelines before submitting your respective cases:

Case has to be submitted by a faculty from an Institute / Hospital (Senior Resident / Assistant Professor / Associate Professor / Additional Professor / Professor / Consultant / Specialist) from their official Email ID's.

Case to be Submitted as a PowerPoint Presentation (PPT) Format in the allotted Power Point Templates.

With the Following Components:

CASE PART - 1:

- 1) Chief Complaints
- 2) History of Presenting Illness
- 3) Any Relevant Past history OR Known Co-Morbidities.
- 4) Examination findings in Detail (ABCDE approach, General Physical Examination, Systemic Examination, Local Examination).
- 5) Initial investigations done in ER:

 (Images of ABG/ECG/USG/X RAY'S /CT Scan/MRI Images to be inserted in the slide with patient details blinded or cropped).
- 6) Treatment in Emergency Department.
- 7) Disposition Admitted to Ward/HDU/ICU.
- 8) Questions to the Opposite Team:
 - i) What is your diagnosis?
 - ii) What key findings in History/Examination/Investigation helped in arriving at the diagnosis?



With Respect to Point 3 and 4 - Any Specific Examination Finding / Investigation which was the key in diagnosing the patient may be withheld in PART-1 for the purpose of a fair and challenging competition.

CASE PART - 2:

Case Diagnosis:

- 1) What examination Finding or Investigation Resulted in the diagnosis
- 2) Discussion/Rationale of how the diagnosis was arrived at.
- 3) Key Learning Points From this Case which Are Relevant for ER Physicians.

PLEASE NOTE:

Patient Information involving

- i) Name of the patient.
- ii) Hospital ID.Should be Cropped in the investigation images before inserting in the slides.

There is no word limit for submitting cases.

Any Images of the patient involving the face should have the eyes closed/blinded.

Mode of Submitting Cases:

Resident case submission- 21-2-2025.

- iv) Mobile Number for Correspondence.



FLOW OF THE DIAGNOSTIC DUEL - CPC COMPETITION:

- Once the cases are received from the teams, the CPC Committee will individually analyse the cases, randomize and allot them to the teams for solving.
- Each team that has submitted a case will receive a case with a CASE NUMBER for solving by 10-02-2025 on the email id from which they submitted their case.
- The solved cases need to be submitted as a Power Point Presentation (PPT) in the allotted Power Point Templates, by 21-02-2025 by 5pm. No submissions or changes in the presentations will be entertained after this date.
- The solved cases will be presented by the PG Resident of the Institute which has received the case.
- The CPC Committee will hold a Zoom Meeting after 26-01-205 (Exact Date and time will be intimated via WhatsApp to participating Institutes/Hospitals) to clarify all further queries related to the competition after the cases are submitted.
- On the day of the competition all presentations will be projected from the conference laptop only, no presentations will be entertained from personal laptops or pen drives.

- No changes in the schedule of presentation will be entertained.
